SECRETARY'S FINANCIAL REPORT, 1973

Income statements and balance sheets for the years 1972 and 1973 are shown in the appended tables. (Historical data for the years 1966–71 may be found in last year's report, published in the June 1973 issue of the Review.)

As the financial statements indicate, the Association's revenues equalled expenditures for a second year, without general foundation support. This relatively favorable outcome was made possible, however, only through increased institutional membership. During 1973, 24 institutions (from 17 countries) were contributing to the Association. It is to be hoped that this number can be increased during the coming year. Regular subscriptions increased only very slightly during 1973, and the number of members remained constant. In an attempt to increase revenues from subscriptions, arrangements have been made for a promotional campaign; this is reflected in the reserve for promotional expenditures.

Rising costs—especially for printing, wages, and postage—are reflected in the expenditure figures. Additional increases in these costs may be anticipated in 1974, and in order to meet these increases the membership voted at its meeting in September to increase subscription rates and dues for the coming two-year period.

The major part of the preparation for two conferences took place during 1973, the 13th General Conference held in Balatonfüred, Hungary, in August-September, and the second Latin American Conference, held in January 1974 in Rio de Janeiro. It was to accommodate the two conferences that the reserve for conference expenditures was increased during 1973. In the event, expenditures for the 13th General Conference were somewhat greater than budgeted, so that the reserve is now in deficit. Travel expenditures for the Latin American conference were met out of a special grant obtained from the Ford Foundation, so that costs chargeable to the Association were only those of reproduction and distribution of papers.
