EUROSTAT SPONSORED CONFERENCE ON THE MEASUREMENT OF INFLATION

31 August-1 September 1999, Cardiff, United Kingdom

Cardiff Business School and the U.K. Office for National Statistics will co-host a special conference in Cardiff on the measurement of inflation. The conference, which is sponsored by the Statistical Office of the European Community, will be held on Tuesday 31 August and Wednesday 1 September 1999.

Consumer price indices have generated considerable debate both with governments increasingly focusing attention on minimising inflation as a key goal of economic policy and the opening up of a debate in the U.S. and Europe on potential sources of bias in their construction. The conference aims to provide users, producers and researchers with a forum for a wide ranging discussion of key isues. Sessions will cover conceptual questions, potential sources of bias, harmonisation of European indices, regional indices, innovations in sampling and data collection, new data sources and methods.

Members of the IARIW and IARNIW are welcome to participate. The conference will include the presentation of research papers and policy forums led by distinguished experts with plenty of time for discussion. There will be no general call for paper. However, the conference will be used to disseminate research results. If you have a paper for dissemination and not presentation you should send a copy on disk using a standard word processing package to the Conference Organiser.

PROJECT ANNOUNCEMENT

TOWARD AN OFFICIAL GLOBAL ECONOMIC DATA SYSTEM ON NONPROFIT INSTITUTIONS

A Joint Project of the United Nations Statistics Division and the Johns Hopkins Center for Civil Society Studies

The Problem

One of the major barriers to improved understanding of the nonprofit sector is the persistent lack of basic statistical data about the scope, structure, financing, and activities of this set of institutions. This lack of information is a product of the way these organizations have been treated in the *System of National Accounts* (SNA) since its inception. Although numerous improvements have been made to virtually all parts of the SNA over the years, little has changed in the treatment of the nonprofit institutions. To this date, they represent the perhaps least understood and least developed institutional part of the SNA.

Under prevailing SNA guidelines, national statistical offices are called on to identify separately, and collect data on, only a small subset of all nonprofit organizations, i.e. those that receive most of their income from households in the form of contributions. These entities form a separate institutional sector in the SNA under the name of *Nonprofit Institutions Serving Households*. But since the portion of the nonprofit institutions primarily serving households and primarily financed by donations is very small in economic size relative to the total, the upshot has been to encourage national statistical offices to ignore this sector almost completely in basic economic statistics. Indeed, of the more than 160 countries that regularly report SNA data, only 30 report any information on nonprofit organizations, and only two provide nearly complete information. Even those that comply more fully with current SNA requirements, moreover, project an image of nonprofit institutions that is grossly understated, frequently treating the sector as a residual category.

The work of the Johns Hopkins Comparative Nonprofit Sector Project¹ in over 30 countries has shown that the portions of the nonprofit sector defined away by the SNA decision rules are quite sizable, indeed quite a bit more sizable than most experts assumed. What is more, this sector seems to be growing at a surprising rate, outdistancing the growth of both government and most industries in the corporate sector in many developed and developing countries. Importantly, the Johns Hopkins Comparative Nonprofit Sector Project has demonstrated the feasibility of gathering more precise and comprehensive data on this sector using techniques that are quite similar to those used for the SNA. Coupled with growing public and governmental interest in this set of organizations, the result has been to make the neglect of the nonprofit sector increasingly untenable.

The Task

To bring the nonprofit sector explicitly into the major process that is now underway to implement the 1993 SNA revisions, a *Memorandum of Understanding* has been signed between the UN Statistics Division and the Johns Hopkins Center for Civil Society Studies. This project has two objectives: to develop a satellite account for the nonprofit sector, and to formulate a set of guidance materials that would help national statistical offices throughout the world improve the SNA coverage and treatment of nonprofit institutions. Under the terms of this agreement, the Center will formulate a procedure for collecting basic economic data about the nonprofit sector internationally and help implement it in a number of countries, and the UN Statistics Division will undertake to publish the *Handbook* resulting from this effort as part of the SNA guidance system and encourage its use by national statistical offices throughout the world.

The major task of this project is the preparation of a handbook to assist national statistical offices in the development of more accurate and complete data on nonprofit institutions. The *Handbook* will include guidelines for the establishment of a satellite account that contains links to related economic and social data systems. By combining organizations that are assigned to other sectors under current SNA rules with those left in the SNA's existing "Nonprofit Institutions Serving Households" sector, the proposed satellite account will create a more complete profile of the entire nonprofit sector, and cover such variables as the number of entities, employment, expenditures, areas of activity, types of revenues, assets and liabilities, capital expenditures, volunteering, philanthropic giving, and transfers and transactions with other components of the economy (national government and international institutions, households, and corporations).

The Process

Because the System of National Accounts is essentially a consensus process, we plan to organize an *International Consultative Group* that will review the work on a regular basis and provide the assurance that the SNA community will demand. Participants on this Consultative Group will include specialists from the major international statistical agencies (UN, World Bank, OECD, Eurostat, and the IMF) as well as academic experts and nonprofit practitioners. As part of this process also, the United Nations Statistics Division will establish an *Expert Group* that will review this work in order to ensure consistency with SNA concepts and definitions.

The Outcomes

The draft Handbook and satellite account system will be pilot tested with data on at least one country to perfect the basic estimating techniques, check the consistency with the SNA, and test the internal parameters for relating the non-profit sector to other components of the economy. To help ensure that national statistical agencies make use of the *Handbook*, we will target a number of countries—representing developed market economies, developing countries, and economies in transition—for implementation and demonstration projects.

The Project

The project is directed by Lester M. Salamon (Johns Hopkins University) and Helmut K. Anheier (London School of Economics). Helen Stone Tice serves as the senior research economist, and Karoly Kovacs as the project's focal point at the UN Statistics Division.
